Purchaser & Breeder agree to enter into this contract under the following binding agreement:

I warranty this puppy/dog to be in good health and free from obvious defects to the best of my knowledge unless otherwise stated in this contract. Immunizations and worming are up-to-date unless otherwise stated. Minor problems such as diarrhea, coccidiosis, wormy stool, etc. are common problems among puppies/dogs and will not be covered by this warranty although every effort is made to sell puppies/dogs free of these problems.

- Purchaser** has 48-72 hours to have the puppy/dog examined by a licensed veterinarian for general health from date of delivery; _____ failure to do so will result in any and all warranties being cancelled other than eyes and hips. Breeder accepts no responsibility for any communicable diseases after 48 hrs. If puppy/dog does not pass general health exam, Purchaser agrees to notify breeder within 24 - 48 hours of said licensed veterinary examine with a copy of the original signed licensed veterinary statement of health. Purchaser may receive another puppy when available, of the same sex, quality and value as determined by the breeder.
- Purchaser** has 4 weeks from the date of delivery to have the puppy/dog's eyes examined by a Board Certified Veterinary Ophthalmologist for heredity eye deformities. If puppy/dog is diagnosed with hereditary eye deformities the Purchaser has 24-48 hours from the date of the exam to notify breeder and provide a copy of the original completed C.E.R.F. form stating the hereditary eye deformities and may receive a replacement puppy when available, of the same sex, quality and value as determined by the breeder.
- Purchaser** has until puppy is 1 year old to have hips x-rayed and evaluated per OFA standards. Purchaser will provide to breeder, within 24-48 hours of notice from OFA with a copy of the written certification from the Orthopedic Foundation for Animals (OFA) stating any hereditary hip deformities. Purchaser may receive a replacement puppy when available, of the same sex, quality and value as determined by the breeder.
- Purchaser** acknowledges that veterinary care, whether preventative or in treatment of any condition is an agreement between two parties, the purchaser and the veterinarian. The breeder is not part of this retail negotiation and will not tolerate attempts to collect after the fact. Breeder is not responsible for buyer's veterinary expenses at any time or under any circumstances.
- Purchaser** hereby releases breeder and agrees to hold harmless for any liability, injuries or damages to persons or property caused by this puppy/dog.
- Purchaser** shall pay any and all shipping costs and health requirement certificates fees.
- Purchaser** shall assume full responsibility for the health, temperament, and appearance of the puppy/dog upon purchase or when puppy/dog leave the premise of the breeder.
- Breeder** cannot guarantee adult size, confirmation, or color of the puppy/dog.
- Deposits** are non-refundable unless breeder is unable to deliver a healthy puppy/dog.
- Entire Agreement:** The terms and conditions herein constitute the entire agreement between the Breeder and Purchaser and supersede all previous agreements and understandings, written or oral with respect to the subject matter hereof.
- Governing Law:** All disputes over the articles of this contract will be determined by the laws of Hamilton County of the State of Texas, without regard to the conflict of laws principals.
- Warranty:** This puppy/dog is warranted only for the purpose of being a companion animal. While it may be capable of performing other functions no warranty is given as to its fitness for any special purpose.

The undersigned purchaser and breeder have read this contract, their signatures affixed herein attest to their complete understanding and agreement of the contents herein. This shall be considered a legal and binding agreement entered into by consenting adults of their own free will.
